Homeowner's Dues:

Due statements are mailed out April 1st and October 1st. Dues should be paid within 30 days. Please contact the board at <u>board@prestontrails.com</u> if you have any questions or circumstances that may cause you to be late on payment.

NOTE: Dues have been increased to help cover the cost of the HOA Management Company. The increase will be reflected in the April 1st statement. Dues will be \$165.00/semiannually (\$330.00 / year).

HOA Management Company:

The board has narrowed the search to two management companies to cover the day to day activities for the HOA.

Once a company is selected, more information will be sent out concerning how to contact them and request forms, etc.

One of the services provided is covenant compliance. Once under contract, they will start driving the neighborhood and send letters to homeowners that are in violation of the covenants, such as:

- Lawn & yard maintenance
- Cars/boats/trailers continuously in driveway or street
- House repairs needed (paint, fences)
