It allows you to connect and communicate with neighbors who have voluntarily registered. It is not a part of the Preston Trails Homeowners Association nor does the Board necessarily endorse it, but homeowners are free to evaluate it and join as they wish. Several of our neighbors have already done so and some have found it beneficial.

# **HOA Management Company:**

The board is investigating the hiring of a management company for day to day activities required of the homeowner's association. As a volunteer board for the past 12 years, we have relied on the uncompensated time contributions of neighborhood homeowners to serve the needs of the Association. Preston Trails is now moving into its teen years and our homes and their improvements are beginning to age and require more upkeep. We are seeing a growing need for covenant enforcement in order to maintain the quality of our neighborhood and the value of our properties. This need is surpassing the amount of time our handful of full-timeemployed members and bookkeeper have available to devote to it. The benefits of an HOA management company will allow us to do that effectively and allow board members to serve more in decision making and representative advisory roles. It will also allow our record keeper the option to enjoy his recent retirement without feeling the obligation of continuing to handle the financial collection, payment and billing needs of the HOA.
